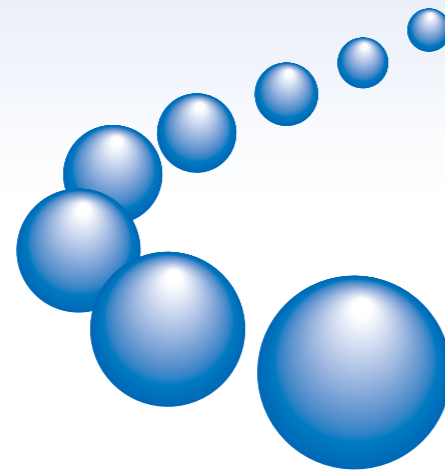

3. Statement of Human and Animal Rights

Dokkyo Journal of Medical Sciences is dedicated to the humane and ethical conduct of all studies involving living subjects. All clinical trials involving human subjects must be registered, retroactively if necessary, to be considered for publication. In studies with human subjects, indicate in the Methods section whether the procedures, including obtaining informed consent, were conducted in accord with the ethical standards of the institution in which the experiments were done or in accord with the ethical standards of the Helsinki Declaration. For experiments with animal subjects, briefly explain the measures taken to insure compliance with established guidelines for humane use and care of laboratory animals, citing the origin of these guidelines.
